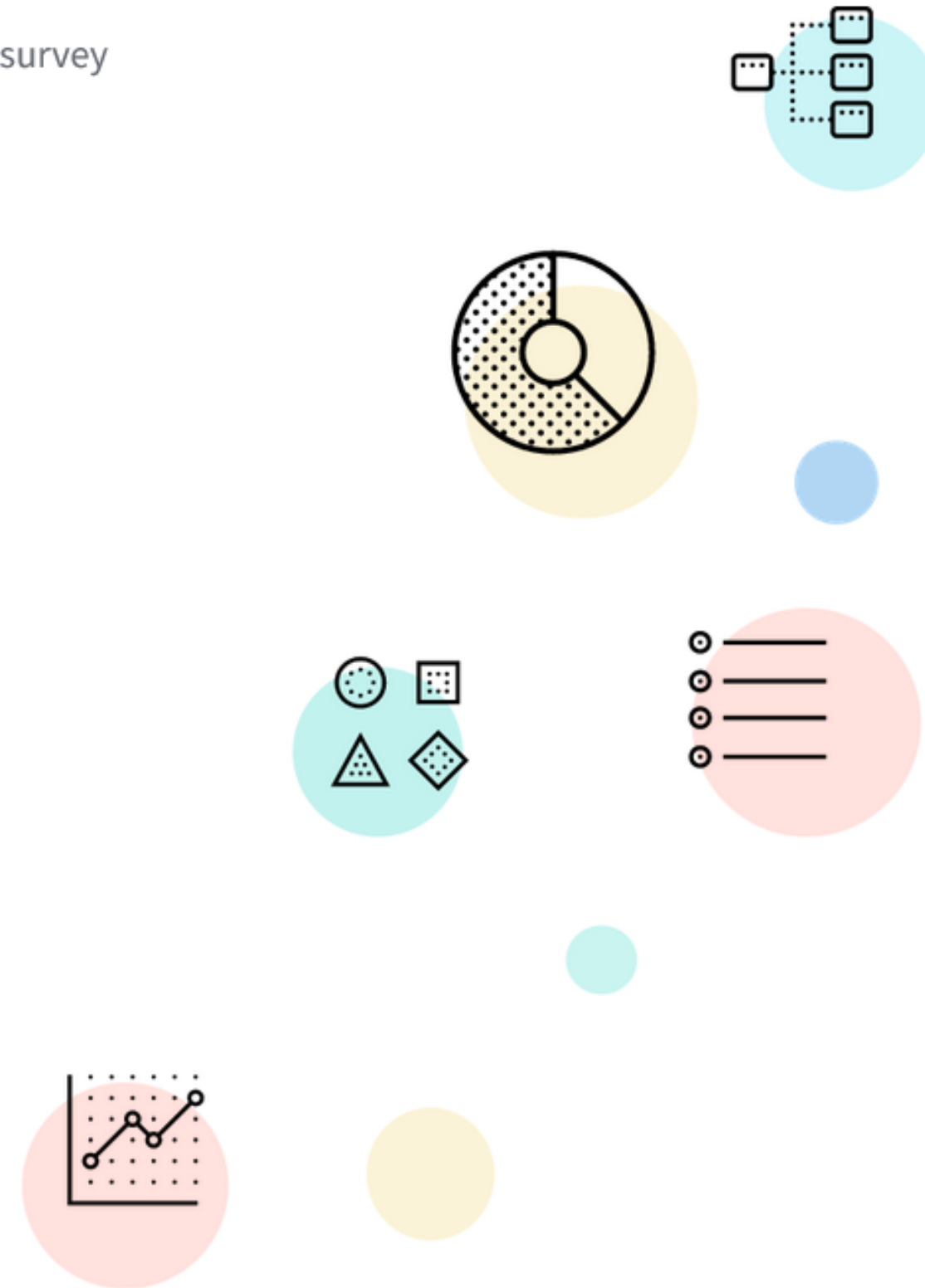

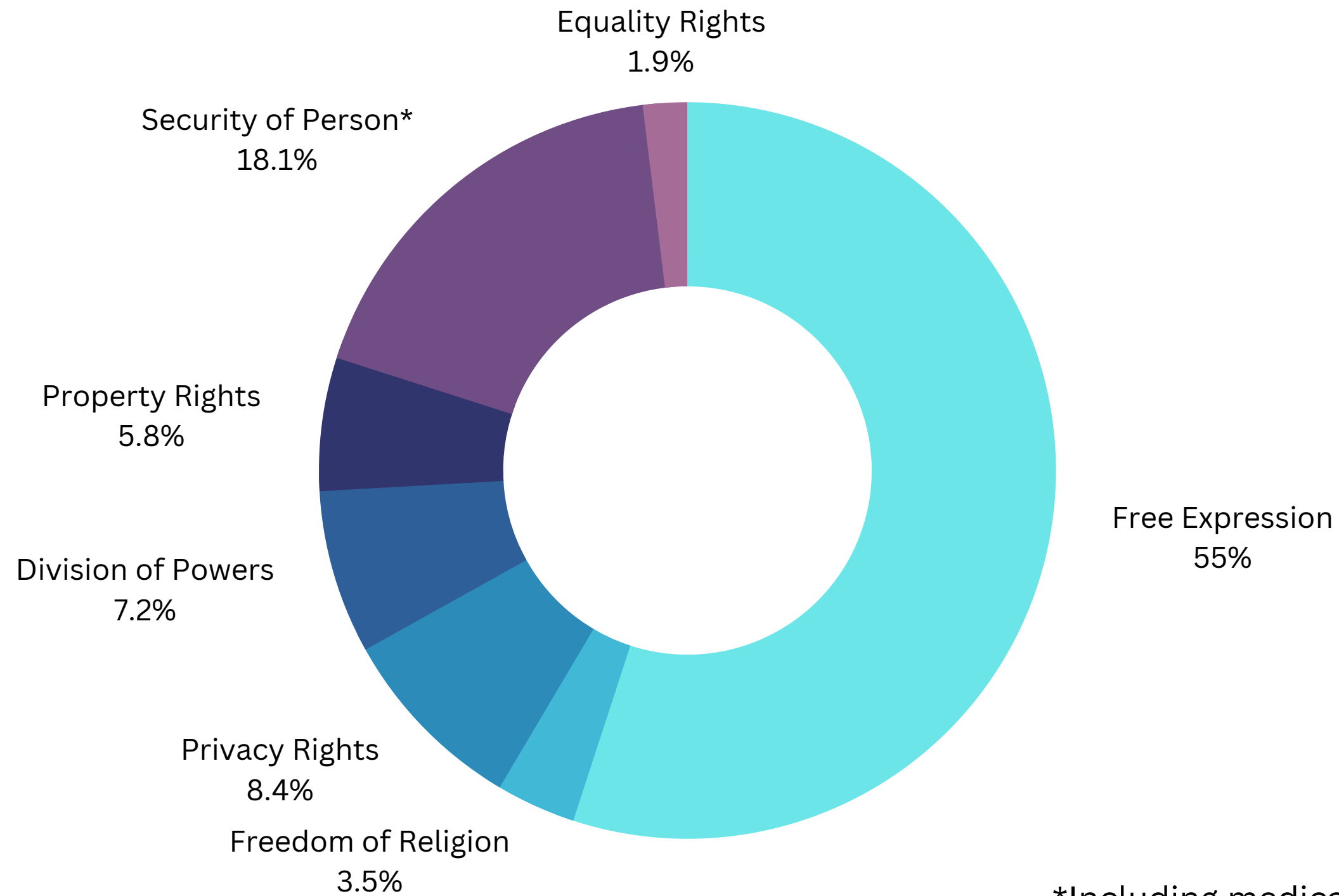


Q1. Is Canada **more** or **less** free since 2019?

Over **94%** of respondents felt Canada has become **less free**.

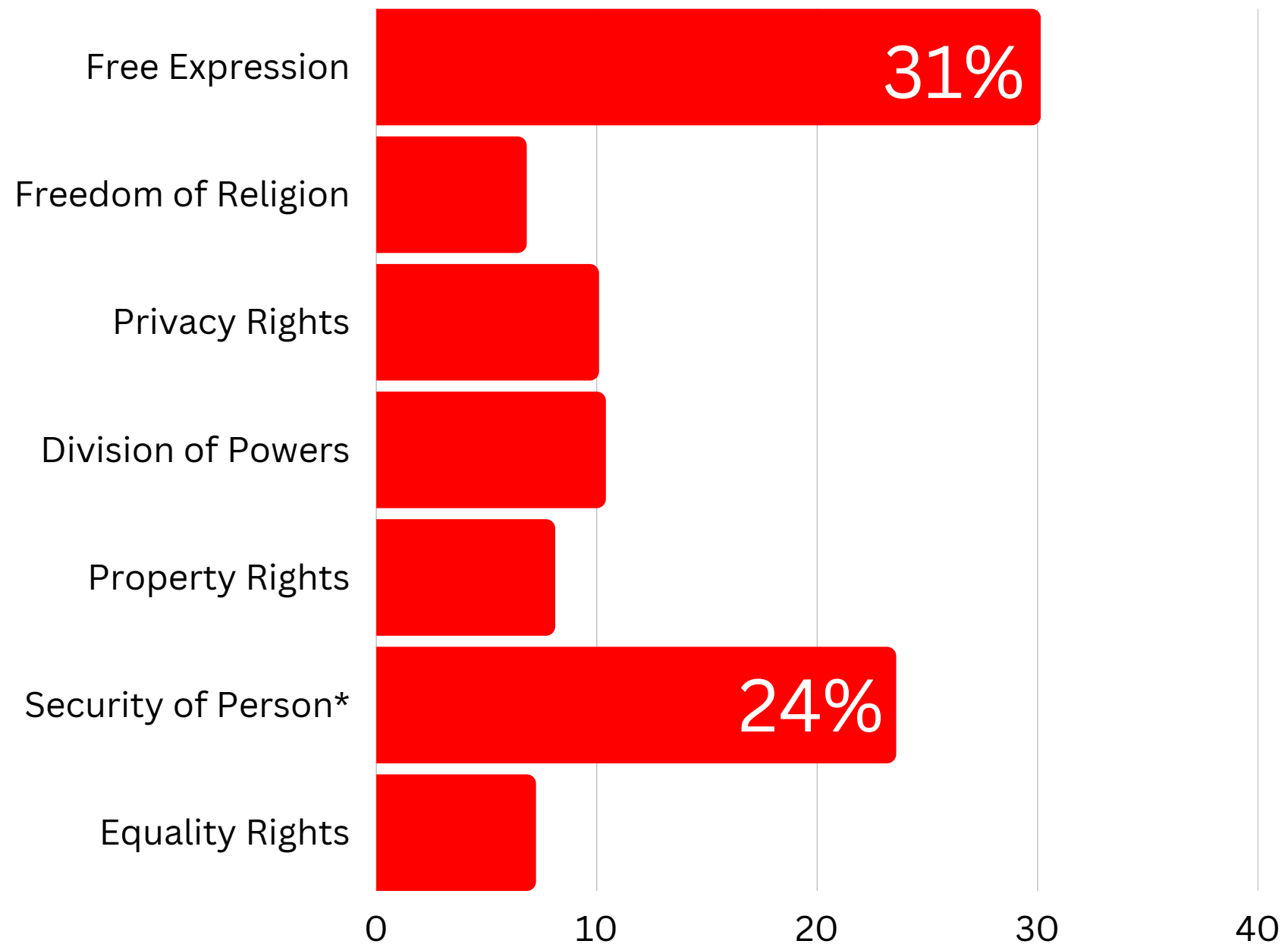
Only 2.67% responded more free.

Q4. What type of **legal cases** are of the greatest importance to you right now?

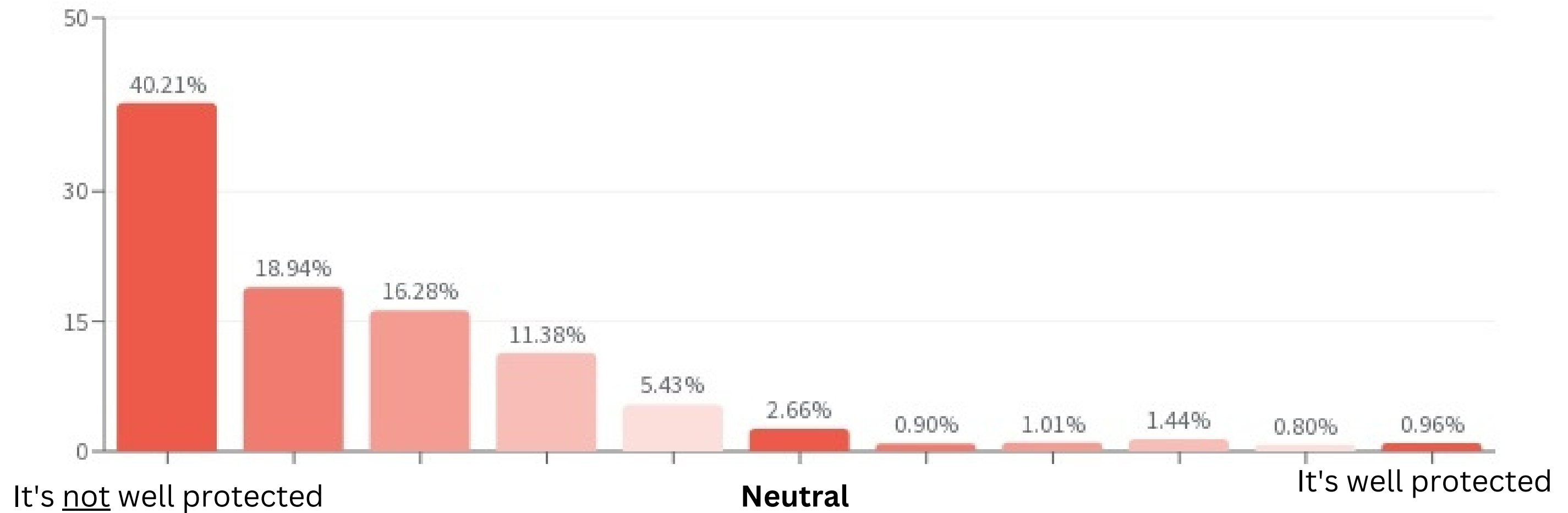

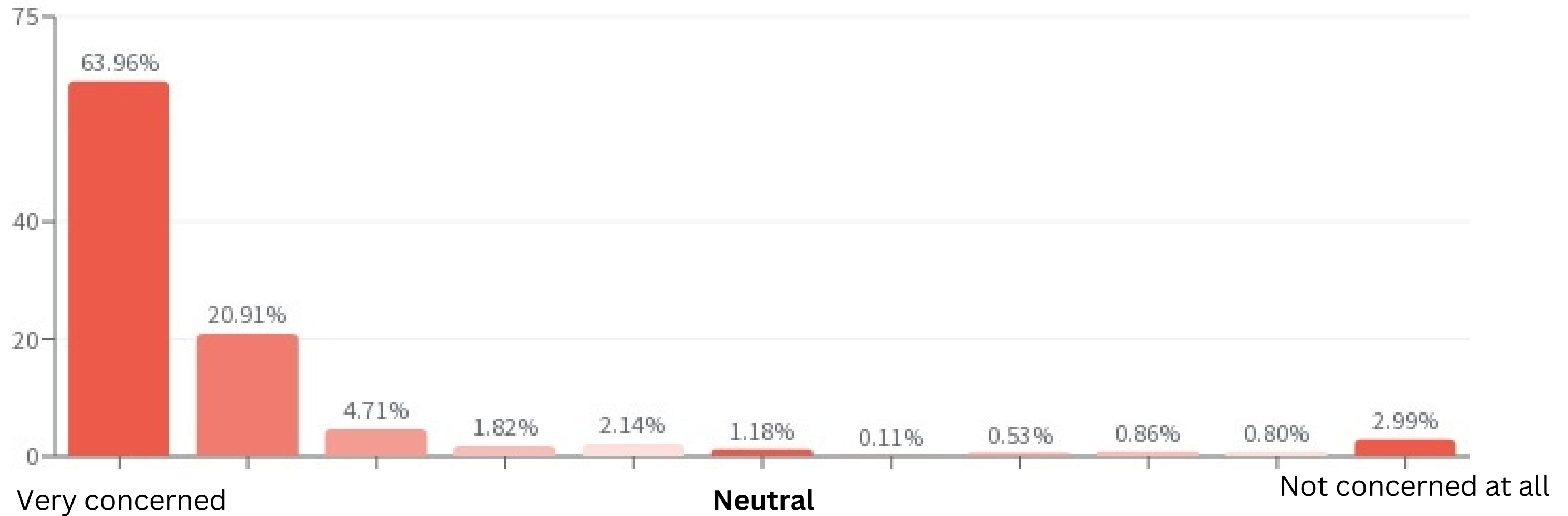
Q10. How do you feel about the overall protection of **freedom of expression** in Canada?



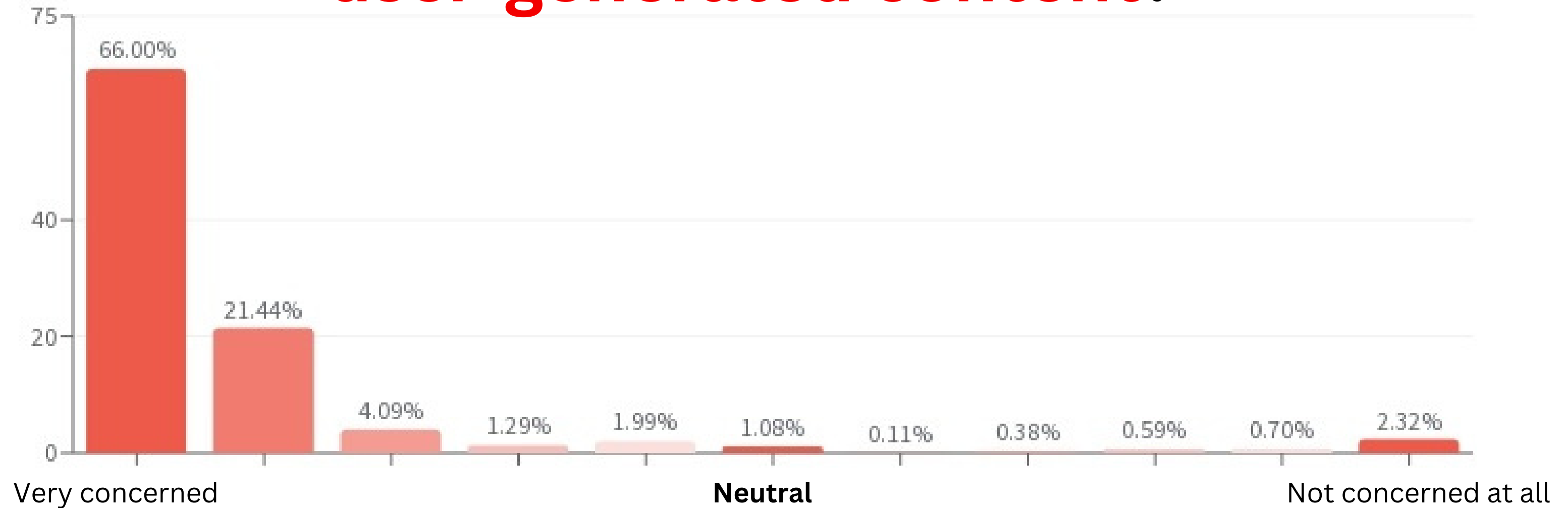
Q14. What level of government do you believe poses the greatest threat to **freedom of expression**?

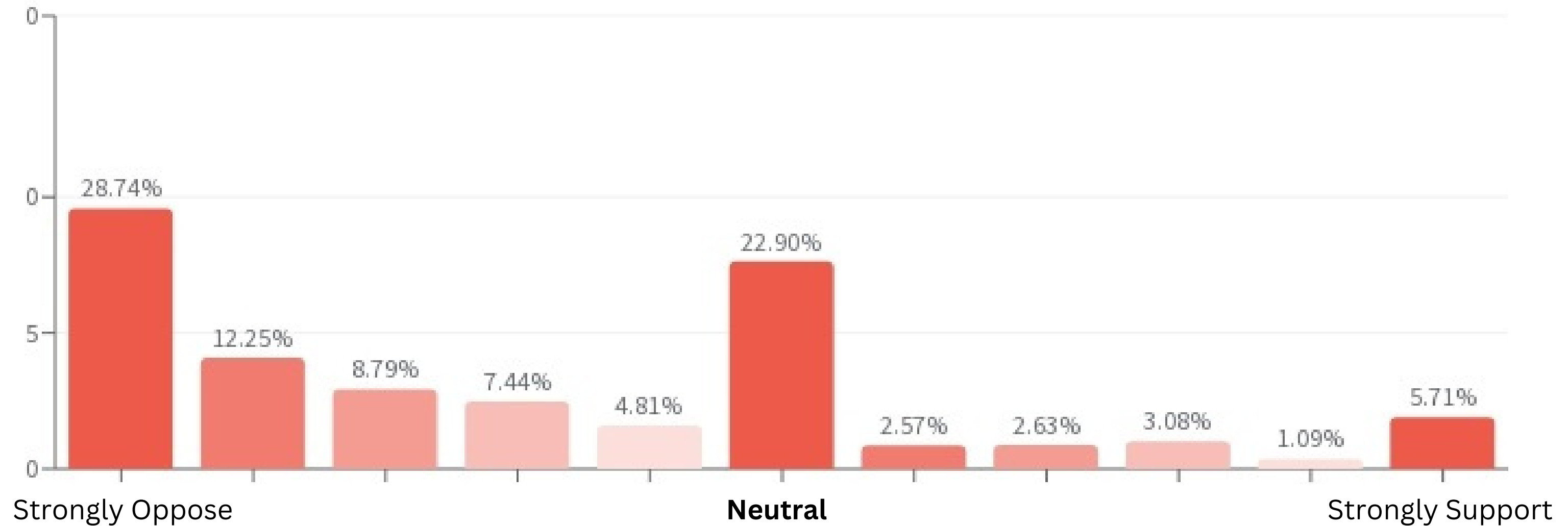
Q15. How concerned are you about professional regulators **restricting the speech** of their members?



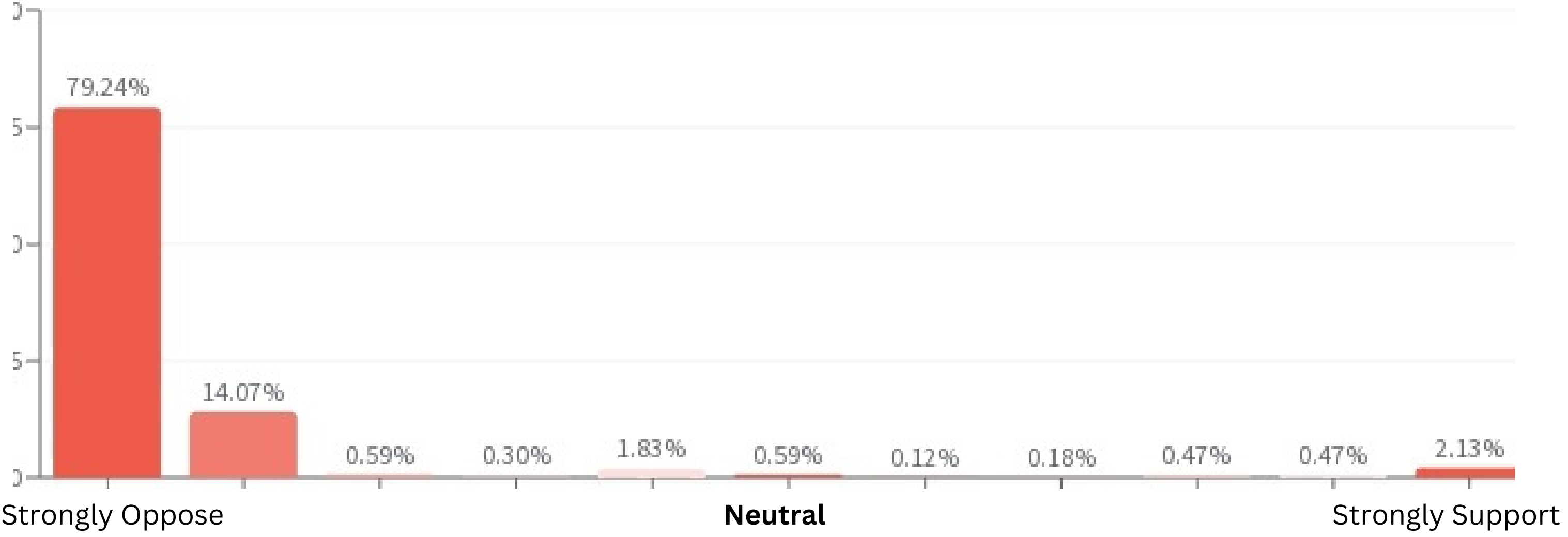
Q16. How concerned are you about government legislation that would allow the CRTC to regulate user-generated content?



Q25. How do you feel about **section 33** in the *Charter* in general?



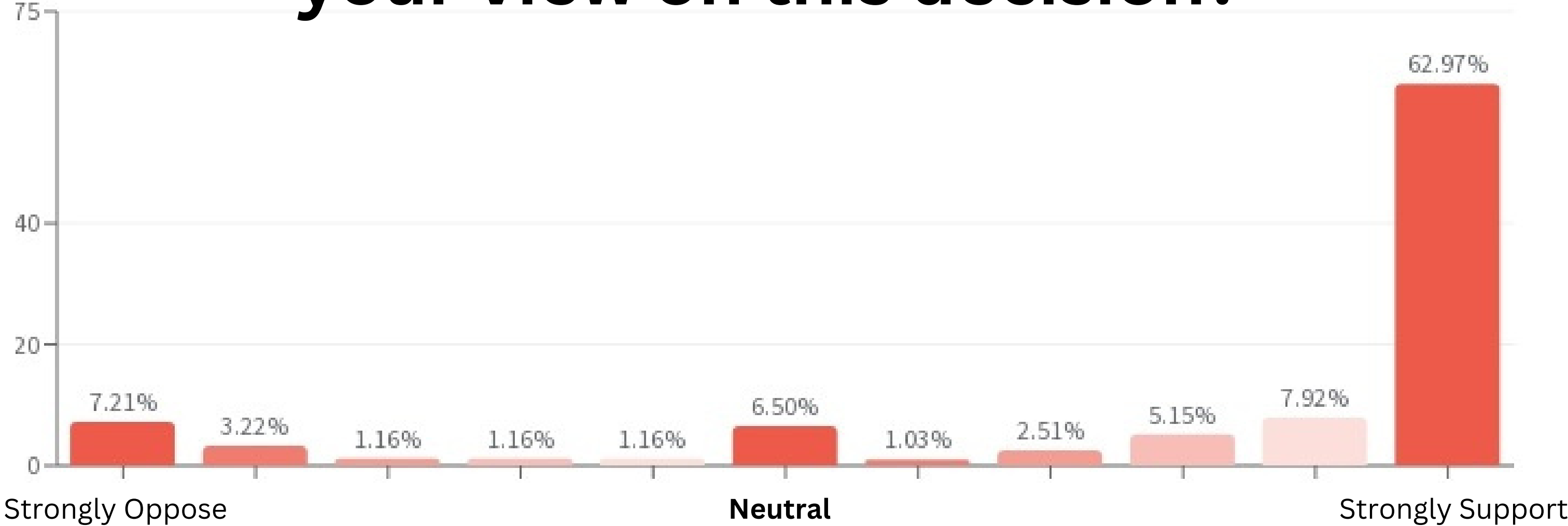
Q30. How do you feel about the federal government's use of the *Emergencies Act*?
